**REPRODUCTION CONDITIONS**

1. Requests for permission to reproduce Content (“Content” means images, video and written material) must be made in writing and include its intended use, the publisher, date of publication and press run. For website usage, the web site address is required.
2. Reproduction fees are payable in advance, whether or not the Content is used. Please note that Content found in the Library and Archives collections may be reproduced at no charge.
3. Permission to reproduce Content must be obtained in advance and covers a one-time use, in one edition, one language, and in all related formats (printed and electronic). Additional language editions, subsequent editions and any related promotional use must be considered as separate requests and will require a new written application and possibly additional fees. Exclusive rights are not granted to any applicant.
4. Alterations: Still images must be reproduced unaltered and in their entirety unless approved in advance by the Mount Vernon Ladies' Association. The reproduction must not be cropped, bled off the page, or have anything superimposed on the image. If a detail is used, the word **DETAIL** must appear in the caption/credit line.
5. Credit: Content must be credited without abbreviation "**Courtesy of Mount Vernon Ladies' Association**" and must appear in immediate proximity to the Content or in the section devoted to image/video credits. If an image is owned by a photographer, “Photograph by (the name of the photographer)” will follow the Mount Vernon credit line. For Content reproduced from the George Washington Digital Encyclopedia, in addition to the Mount Vernon credit line, the author’s name as listed in the Encyclopedia entry must be cited as written.
6. Permission for cover art for a book jacket or DVD will only be considered upon receipt of a cover design and written application for such use. An additional fee is required for cover use.
